Summary

- 1. This report seeks Members determination of an application for the grant of a premise licence, which has been made under the Licensing Act 2003.

Background

Promotion of Licensing Objectives

- 7. The operating schedule submitted by the applicant shows that the licensing objectives would be met as follows:
- 8. The prevention of crime and disorder
 - a) CCTV is installed on the premises covering the entrance and exits, the showroom area and the serving area.

9. Public safety

- a) Signage will be in place concerning fire exits.
- b) Regular equipment checks will be conducted.
- 10. The prevention of public nuisance
 - a) Signage will be placed to encourage clients to leave the premises quietly
- 11. The protection of children from harm:
 - a) A "Challenge 25" policy will be adopted along with a "service refusals" log book.

Special Policy Consideration

12. This premise is not located within the special policy area.

Consultation

13. Consultation was carried out by the applicant in accordance with s13, and s17 (5) of the Act and Regulation 42, Parts 2 and 4 of the Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005, which concern the displaying of a notice on the premises and an advertisement in a local paper giving details of the application and serving a copy of the application on all responsible authorities. The applicant complied with all statutory requirements. In addition the relevant ward councillors and/or parish council were notified by way of register. 14. All procedural aspects of this application have been complied with.

Summary of Representations made by Responsible Authorities

- 15. North Yorkshire Police have mediated with the applicant who has agreed to a number of conditions being added to the licence if granted. These conditions are show at Annex 2
- 16. The Council's Environmental Protection Unit have mediated with the applicant who has agreed to remove the provision for both live and recorded music from the application, amend Sunday opening times to start at 09:00hrs and to add 2 conditions. These proposals are shown at Annex 3.

Summary of Representations made by Parties other than Responsible Authorities

- 17. Relevant representations have been received from 6 persons listed at Annex 4 and their representations are shown at Annex 5.
- 18. A map showing the general area around the venue is attached at Annex 6.

Planning Issues

19. The council's development Management team have been in contact with the applicant regarding the required planning permissions and will deal with any issues within their remit.

Options

- 20. By virtue of s18 (4) of the Act, the Committee have the following options available to them in making their decision: -
- 21. Option 1: Grant the licence in the terms applied for.
- 22. Option 2: Grant the licence with modified/additional conditions imposed by the licensing committee.
- 23 Option 3: Grant the licence to exclude any of the licensable activities to which the application relates and modify/add conditions accordingly.
- 24. Option 4: Reject the application.

Analysis

- 25. The following could be the result of any decision made this Sub Committee:-
- 26. Option 1: This decision could be appealed at Magistrates Court by any of the representors.
- 27. Option 2: This decision could be appealed at Magistrates Court by the applicant or any of the representors.
- 28. Option 3: This decision could be appealed at Magistrates Court by the applicant or any of the representors.
- 29. Option 4: This decision could be appealed at Magistrates Court by the applicant.

- 30. The Licensing Act 2003 has 4 objectives the prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm.
- 31. The promotion of the licensing objectives will support the Council's priorities to protect vulnerable people, build strong communities, and protect the environment.
