<b>Disclosable Pecuniary Interests</b>	
<b>1. Employment, Office, Trade, Profession or Vocation</b>

"Securities" does not include building society accounts but includes securities of all other descriptions such as shares, debentures, stock, loan stock and units of a collective investment scheme	None
