<b>Disclosable Pecuniary Interests</b>	
<b>1. Employment, Office, Trade, Profession or Vocation</b>	
You should disclose any employment, office, trade, profession or vocation carried on for profit or gain, including the name of any person or body who employs or has appointed you	NONE

<b>2. Sponsorship</b>

<b>3. Securities</b>	
You should detail any beneficial interest in securities of a body which has to your knowledge a place of business or land in the Parish and <b>either</b> the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, <b>or</b> one	NONE

<p>hundredth of the total issued share capital of any class of shares issued.</p> <p>“Securities” does not include building society accounts but includes securities of all other descriptions such as shares, debentures, stock, loan stock and units of a collective investment scheme</p>

<p><b>4. Contracts</b></p>
