You should disclose any employment, office, trade, profession or vocation carried on for profit or gain, including the name of any person or body who employs or has appointed you	Retired

You should detail any beneficial interest in securities of a body which has to your knowledge a place of business or land in the Parish and either the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, or one	n/a
