Disclosable Pecuniary Interests

1. Employment, Office, Trade, Profession or Vocation

You should disclose any employment, office, trade, profession or vocation carried on for profit or gain, including the name of any person or body who employs or has appointed you

RETIRED.

And of your spouse/civil partner (or person with whom you are living as such) of which you are aware

2. Sponsorship

You should declare any payment or provision of any other financial benefit (other than from the Council) made or provided within the last 12 months in respect of expenses incurred by you in carrying out your duties as a member, or towards your election expenses.

Note - This includes any payment or financial benefit from a trade union

3. Securities

You should detail any beneficial interest in securities of a body which has to your knowledge a place of business or land in the Parish and **either** the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, or one

(excluding any easement, or right in or over land which does not carry the right to occupy or receive income). For these purposes land includes buildings and so if you own or are the tenant of your house you will have an interest in land.	4. WHITE ROSE AVE NEW ARSWICK YORK YO32 4AG.

You must reveal the name of any person from whom you have received a gift or hospitality with an estimated value of at least £50 which you have received in your capacity as a member of the Council.
