1. Employment, Office, Trade, Profession or Vocation	
You should disclose any employment, office, trade, profession or vocation carried on for profit or gain	Retired

3. Securities	
You should detail any beneficial interest in securities of a body which has to your knowledge a place of business or land in the Parish and either the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, or one hundredth of	Nil

<p>4. Contracts</p>	
<p>You should detail any current undischarged contract made between you, or a body in which you have a beneficial interest, and the Council under which goods or services are to be provided or works are to be executed</p> <p>You have a beneficial interest in a body which is a firm in which you are a partner or a body corporate of which you are a director, or in the securities of which you have a beneficial interest</p>	<p>None</p>
